I understand that my canoe/watercraft and all equipment belonging to the canoe/watercraft is stored at my own absolute risk and that the Surfers Paradise Outrigging Canoe Club Inc (the Club) will accept no responsibility or liability for any loss or damage to the canoe/watercraft whilst it is stored.

I hereby indemnify the club against any claim whatsoever arising out of any loss of or damage to my stored canoe/watercraft and for any damage to Club property caused by my canoe/watercraft.

I agree that any insurance of my canoe/watercraft will be my sole responsibility. The term "canoe" includes the ama, iakos and all gear relating to the canoe/watercraft stored at the clubs' grounds.

I accept and will abide by the following conditions:

1. The canoe/watercraft is to be stored only in its allocated position.
2. The canoe/watercraft shall be removed from the club storage rack within 7 days of a written request from the Club Committee for such reasons as this committee may determine in its absolute discretion including:
  - a. Failure to pay the storage fee imposed by the Club Committee
  - b. Failure to store the canoe/watercraft correctly
  - c. Failure to enter into a new storage agreement on the expiration of this Agreement
3. I will remove my canoe/watercraft from Club storage within 7 days of:
  - a. Sale of the canoe/watercraft. If sold to another person, storage rights DO NOT transfer to the new Owner. Such a new owner will need to take their place on the waiting list, if necessary.

I agree to pay the rental charges fixed by the Club for storage of my canoe/watercraft which is currently set at \$100 per financial year for club members and \$150 per financial year for non members (or as varied by the committee from time to time) within 7 days of signing this agreement. I acknowledge the Club reserves the right to review the storage fee at any time.
